TO THE ABOVE FEES, ADD \$300.00 APPLICATION FEE.

NALMLS DUES FOR REALTOR MEMBERS ARE \$117.00 PER QUARTER. ADD \$200.00 NEW MEMBER APPLICATION FEE FOR NEW MEMBERS ONLY.

NALMLS dues are prorated: \$117.00 divided by 3=\$39.00 each month. So if you join:

1st month of the quarter \$117.00

2nd month of the quarter \$78.00

3rd month of the quarter \$39.00

Display key without insurance is **\$154.41 + activation fee of \$90.00 =\$244.41** (Billed in March for the next 12 month period starting April 1)

Display key with **insurance \$244.41 + \$25.00 for the insurance \$269.40** (Billed in March for the next 12 month period starting April 1).

Smart Phone:

basic key service **\$18.47** a month taken off credit card automatically every month

Expanded service (listings etc) **\$26.55** a month taken off credit card automatically each month.

AAR Policy & Procedures Manual Section 7 Financial Policies & Procedures

Section 7.1.3 Affiliates

3. Affiliates: Each Affiliate firm (at a primary mailing address) will pay state dues of \$170.00 per annum and local dues annually through their primary local association.

When joining additional local associations, the same firm shall pay local association dues only with the option of paying state dues and designating an additional contact and mailing address.

Our local affiliate dues are \$100.00 + State dues of \$170.00 = \$270.00 (this is for the company and one designated contact) If more than one person in each company wants membership they will each pay \$100.00 local dues, but no state dues.
